



Fundraising Agreement

Thank you for committing to raise money for FOP Friends. We are very grateful for your support and wish you the best of luck with your fundraising and the challenge itself. Please read the following fundraising agreement carefully.

By participating in this run or challenge and accepting a place through FOP Friends, you agree to the terms and conditions below. These terms constitute the fundraising agreement between FOP Friends and you.

- I understand that the event is not organised by FOP Friends, but by a third-party event organiser. It is my responsibility to read any terms and conditions issued by the event organiser and comply with these.
- I am medically and physically fit and understand that I take part in this event at my own risk. FOP Friends won't be held responsible for any injury or illness related to my training or taking part in this event.
- I understand that FOP Friends may need to share my name and email address with the event organiser and where necessary, with other third parties involved in the administration of the event.
- When the event organiser contacts me, I will complete their registration process because I understand this is required to confirm my entry. I understand that if I fail to do this before the deadline specified by FOP Friends, I won't be allowed to take part in the event and my place will be cancelled. My registration fee will also be non-refundable.
- I understand that my registration fee (where applicable) is non-refundable and does not count towards my fundraising target.
- I understand that, where FOP Friends has paid part or all of the cost of the event registration fee, my participation is based on a commitment to raise funds for FOP Friends.
- I understand that my place in the event is non-transferable.
- I commit to doing my best to raise the full fundraising target. If I think I won't be able to reach this target, I will get in touch with FOP Friends to discuss this.
- I will collect and pay all raised funds for FOP Friends within four weeks of the completion of the event.
- I understand that donations made to FOP Friends are non-refundable, even if I withdraw from the event or fail to take part for any reason.
- I acknowledge that funds raised for FOP Friends are held in trust and I am legally responsible for ensuring they are received by the charity.
- If I cannot participate for any reason, I will notify FOP Friends as soon as reasonably possible.
- I commit to fundraising lawfully and maintaining FOP Friends' reputation. I will comply with all current and relevant fundraising rules and regulations.
- I will use an industry-accepted platform, preferably Enthuse, to collect funds fopfriends.enthuse.com. FOP Friends can assist with the setting up of a fundraising page.
- For other methods, I am responsible for the secure handling of funds. Please contact FOP Friends for a Sponsor Form.
- I acknowledge that FOP Friends may terminate the agreement if I breach any of these terms. FOP Friends reserves the right to cancel my place if I fail to comply with any terms or fundraising obligations.
